4. The above candidate is required to produce Community Certificate in original issued by the competent authority, in case he belongs to SC/ST/BC Community.

5. The services of the appointee are liable to be utilized either as Office Attender/Watchman/Sweeper/Gardener or for attending to any other duties entrusted to him from time to time according to the exigencies of work.

6. The appointee should execute a contract of service with the University in the prescribed form on a non-judicial stamped paper worth Rs.5/- (Rupees Five only) as per the provisions of the Andhra Pradesh Open University Act, within one month from the date of his joining duty failing which his salary will not be claimed.

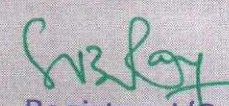

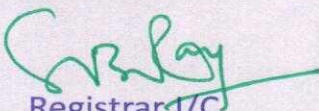
